## OFFER DESCRIPTION

1 — Pursuant to articles 6, 15, 15-A and 19 of Decree-Law No. 185/81 of 1 July, amended and added by Decree-Law No. 69/88 of 3 March, Decree-Law No. 207/2009, of August 31, and Law No. 7/2010 of 13 May, hereinafter referred to as ECDESP, as well as Regulation No. 558/2010, of tenders for the hiring of teaching staff of the Polytechnic Institute of Santarém, published in the Portuguese Official Journal, 2nd grade, No. 122, of June 25, 2010, and other Legal requirements in force, it becomes publicly announced that by order of June 20, 2020, of the Dean of the Polytechnic Institute of Santarém, is open, for the period of 30 working days from the publication of this announcement in the Portuguese Official Journal, an international application procedure to recruit one assistant professor, under labor contract in permanent

public functions, for the disciplinary area of informatics, for the School of Management and Technology of Santarém.

2 — The tender is valid for this vacancy, expiring with its completion.

3 — The tender may be applied by applicants who are under the conditions laid down in article 17 of the ECDESP: the holders of the degree of doctor or the title of specialist, in the area or a close area to which the tender is opened.

4 — Applications should be formalized upon request, addressed to the Dean of the Polytechnic Institute of Santarém, delivered, or sent by mail with deliver-receipt, at the Polytechnic Institute of Santarém, Complexo Andaluz, Apartado 279, 2001-904 Santarém, Portugal, until the deadline for submission of applications referred to in paragraph 1 of this announcement.

5 — The requirements must include the following elements: Full name, affiliation, date and place of birth, number and date of the identity card and issuing service, postal and electronic address, telephone number, civil status, academic degree and its final classification, professional category and position that s/he currently occupies, identification of the tender to which is the application, and identification of the number of the Portuguese Official Journal that publishes the this announcement, and all the elements that allow to judge on the skills of the applicants.

6 — Applicants must instruct their requirements with the following documents:

a) Certificate of criminal record;

b) Proof of physical robustness and psychic profile for the exercise of public functions;

(c) Mandatory vaccination bulletin duly updated;

d) Proof of being in the legal conditions referred to in paragraph 3 of this announcement;

e) Detailed Curriculum Vitae, dated, signed and mandatorily organized in accordance with the parameters and evaluation criteria defined in this announcement, and must be delivered seven copies in paper support, and one in digital support;

f) A copy in digital support of the works and evidence of the activities mentioned in the curriculum vitae;

g) Other diplomas or certificates of the courses mentioned in the curriculum vitae, as well as other documents that facilitate the judgement on the skills of applicants for the exercise of the functional content of the category to which applies;

i) Complete list of the documentation submitted.

7 — The submission of the documents referred to in points (a), (b), and (c) of the preceding paragraph shall be waited by applicants who declare in their respective requirements, in separate points and under a commitment of honor, the accurate situation in which they are in

relation to the content of each of them.

#### 8 - Evaluation criterion in absolute merit.

If the applications duly instructed in accordance with the requirements of this announcement, the admission on absolute merit of the candidates will depend on the possession of a global curriculum, which the jury considers having scientific and pedagogical merit compatible with the disciplinary area for which the contest is opened, cumulatively with the presentation by the candidate of at least two articles published or definitively accepted for publication, in the area where the competition is opened, in scientific journals, with an impact factor attributed by Clarivate Analytics (published in the Journal Citation Reports), indexed in the Web of Science or Scopus.

#### 9 — Selection methods and evaluation criteria.

9.1-The evaluation method to be used is the curricular evaluation, through which it is aimed to evaluate the technical-scientific performance, the pedagogical capacity, and the exercise of other relevant activities in the area in which the tender is opened, being considered the following criteria, to which was given the indicated weighting:

- a) Technical-scientific performance (TSP): 50%;
- b) Pedagogical capacity (PC): 30%;
- c) Other relevant activities (ORA): 20%.

9.2-In the evaluation of technical-scientific performance (TSP) will be considered the following parameters:

1. Academic Training (AT), (weighting of 20%), to be evaluated through the following items:

- . Holder of the Degree of Doctor or The Title of Specialist in the Area of Informatics;
- . Postgraduate and other courses considered relevant in Informatics.

2. Research and development projects in informatics (RDP), (weighting 20%), to be evaluated through the following items:

- . Coordinator of research projects (completed/ongoing) with evaluation and external financing (e.g. FCT, European projects);
- . Coordinator of other research projects (completed/ongoing);
- . Collaborator of research projects (completed/ongoing) with evaluation and external financing (e.g. FCT; European projects);
- . Collaborator of other research projects (completed/ongoing).

3. Publications and communications in informatics (PCI), (weighting of 40%), to be evaluated

by the following items:

- . Publications of articles in scientific journals indexed in Web of Science /SCOPUS;
- . Articles accepted for publication, definitely, in scientific journals indexed in Web of Science /SCOPUS;
- . Publications of technical and scientific articles in other journals with peer-review (maximum of 5 articles);
- . Author or coauthor of technical-scientific books;
- . Publications of book chapters with peer-review (maximum of 5 chapters);
- . Communications presented at scientific events with peer-review (maximum of 10 communications).

4. Other technical-scientific activities in informatics (OTA), (weighting 20%), to be assessed by the following items:

- . Effective member of the research unit financed by the FCT, or equivalent entity;
- . Member of scientific committees or conference organizing committees or equivalent scientific events (maximum of 5 events);
- . Supervisions of completed PhD theses (maximum of 5 supervisions);
- . Supervisions of completed master's dissertations/projects/ internships (maximum of 5 supervisions);
- . Participation in academic evidence and competition tenders of teaching and research careers in the last 5 years (maximum of 10 participations);

9.3-In the evaluation of pedagogical capacity (PC) will be considered the following parameters:

1. Experience and dedication to teaching in informatics (EDT), (weighting of 70%), to be evaluated through the following items:

- . Teaching experience in polytechnic or university higher education in the last 10 years;
- . Experience in the teaching of curricular units in English in the last 10 years
- . Number of curricular units taught with different contents in the last 10 years;
- . Adoption of innovative teaching-learning methodologies in the last 3 years;
- . Supervision and follow-up of students in internship in the last 5 years (maximum of 10 supervisions);
- . Participation in events of pedagogical character in the last 5 years (maximum of 5 events).

2. Elaboration of pedagogical material in informatics (EPM), (weighting 30%), to be evaluated

through the following items:

- . Author or coauthor of teaching support books in the last 5 years;
- . Elaboration of text manuals to support teaching that cover at least 75% of the curricular unit topics in the last 5 years (maximum of 1 element per curricular unit with different contents);
- . Preparation of other printed notes supporting teaching that cover at least 75% of the curricular unit topics in the last 5 years (maximum of 2 elements per curricular unit with different contents).

9.4-In the evaluation of the other relevant activities (ORA) will be considered the following parameter:

- . Other relevant activities in Informatics in the last 10 Years (ORA), to be evaluated through the following items:
- . Professional experience in activities of relevance outside the academic environment;
- . Exercise of functions of direction, management, and participation in collegiate bodies.
- . Coordination, execution and development of projects or activities of practical character inserted in the socio-professional environment;
- . Participation in international mobility programs such as Erasmus+ (maximum of 5 mobilities);
- . PhD or post-doctoral scholarship funded by the FCT or equivalent entity.

10 — The jury is responsible for defining the evaluation grid for each evaluation parameter referred to in the preceding paragraph of this announcement.

11 — The evaluation and final classification system is as follows:

- a) The final ranking (FR) of applicants is expressed in the numerical scale from 0 to 100.
- b) The final ranking of applicants results from applying of the following formula:

$$FR=0,5 TSP (0,2 AT + 0,2 RDP+0,4 PCI+0,2 OTA) +0,3 PC (0,7 EDT+0,3 EPM) +0,2 ORA$$

With the following acronym meanings:

FR – Final ranking;

TSP – Technical-scientific performance;

PC – Pedagogical capacity;

ORA – Other relevant activities.

11 — The jury will have the following composition:
