

Polytechnic Institute of Santarém

Public Notice

Opening of a competitive tender for a career as a teacher in polytechnic higher education in the category of assistant professor in the area of Sociology for the Higher School of Education of the Polytechnic Institute of Santarém.

- 1 Under the terms of articles 5, 15, 15-A and 17 of Decree-Law no. 185/81, of 1 July, as amended and added to by Decree-Law no. 69/88, of 3 March, Decree-Law no. 207/2009, of 31 August, and Law no. 7/2010, of 13 May, hereinafter referred to as ECPDESP, as well as Regulation no. 559/2010, of the Tenders for the Hiring of Teaching Staff at the Polytechnic Institute of Santarém, published in the Official Gazette, 2nd series, no. 122, of 25 June 2010, and other legal provisions in force, it is hereby made public that, by order of the President of the Polytechnic Institute of Santarém, of 12 September 2022, a call for tenders is open, for a period of 30 working days from the publication of this notice in the Official Gazette, for the recruitment of an assistant professor, on an indefinite public service contract, for the area of Sociology.
- 2 The tender is valid for this vacancy and will expire when it is filled.
- 3 Applicants who fulfil the conditions set out in article 17 of the ECPDESP may apply for this tender: those who hold a doctorate or specialist qualification in the area or area related to that for which the tender is being held, with a special focus on Social and Educational Intervention Policies and Projects.
- 4 Applications must be formalised by means of an application, addressed to the President of the Polytechnic Institute of Santarém, delivered or sent by post with acknowledgement of receipt, to the Polytechnic Institute of Santarém, Complexo Andaluz, Apartado 279, 2001-904 Santarém, by the deadline for submitting applications referred to in paragraph 1 of this notice.
- 5 The application must include the following information: full name, filiation, date and place of birth, number and date of the identity document or Citizen Card, postal and email address, telephone number, academic degree and respective final classification, professional category and position currently held, identification of the tender to which they are applying and the Official Gazette that published this notice, as well as all the information that allows us to judge the applicants' aptitudes.
- 6 Applicants must submit the following documents with their application:
 - a) Declaration that they are not disqualified from exercising public functions or are not disqualified from exercising the functions for which they are applying;



- b) Criminal record certificate;
- c) Document proving physical robustness and psychological profile for the exercise of public functions;
- d) Up-to-date compulsory vaccination record;
- e) Document proving that they fulfil the legal conditions referred to in paragraph 3 of this notice;
- f) Detailed Curriculum Vitae (CV), dated, signed and organised in accordance with the parameters and assessment criteria defined in this notice, with direct reference by means of numbering or hyperlinks to the respective proofs, to be submitted in digital format (USB flash drive) and together with a paper copy;
- g) A digital copy of each work and proof of activities mentioned in the CV.
- h) Other diplomas or certificates from the courses mentioned in the CV, as well as other documents that facilitate the formation of a judgement on the applicants' aptitude for the exercise of the functional content of the category to which they are applying.
- *i*) Proficiency in spoken and written Portuguese, which may be assessed by listening to the applicants;
- j) Complete list of documentation submitted;
- *k)* Declaration of authorisation to share personal data (available on the IPSantarém's website: www.ipsantarem.pt/rh/procedimentos-concursais-pessoal-docente/)
- 7 The submission of the documents referred to in subparagraphs a), b) and c) of the previous paragraph is waived for applicants who declare in their application, in separate subparagraphs and under oath, their precise situation with regard to the content of each of them.
- 8 False declarations will be punished in accordance with the law.
- 9 Applicants with foreign qualifications must provide proof of recognition, equivalence or registration of the respective degree under the terms of the applicable legislation.
- Failure to submit the documents proving the requirements set out in points 4, 5, 6 and 9 (if applicable) of this notice, or submitting them after the deadline stipulated in paragraph 1 of this notice, will result in the application being rejected.
- Failure to submit the documents relating to the CV submitted by the applicant or the illegibility of the respective documents will result in the elements they are supposed to prove not being valued.
- Selection and ranking criteria The selection and ranking criteria and their associated points
 are set out in the grid attached to this notice.
- In the event of a tie, the jury shall consider the following successive tie-breaking criteria:
 - a) Best score obtained in the Technical-Scientific and Professional Dimension (TSPD);
 - b) Best score obtained in the Pedagogical Dimension (PD);



- c) Best score obtained in Other Relevant Activities (ORA).
- When applying these criteria, the maximum limits resulting from the application of the final classification formula are not taken into account.
- 14 Assessment and selection.
- 14.1 The assessment method to be used is curriculum weighting, which aims to assess the Technical-Scientific and Professional Dimension, the Pedagogical Dimension and the exercise of Other Relevant Activities in the area in which the tender is open, with the following maximum scores being awarded:
 - a) Technical-Scientific and Professional Dimension (TSPD): maximum of 40 points;
 - b) Pedagogical Dimension (PD): maximum of 40 points;
 - c) Other Relevant Activities (ORA): maximum of 20 points.
- The Jury is responsible for defining the assessment grid (see Annex to the Notice) for each assessment dimension referred to in the previous paragraph of this notice.
- Assessment and final classification system.
- 16.1 The assessment and final classification system is as follows:
 - a) The Final Classification (FC) of applicants is expressed on a numerical scale of 0 to 100.
 - b) All results will be rounded up to the nearest hundredth.
 - c) The final classification of the applicants results from the application of the following formula:

FC= TSPD + PD + ORA

In which:

TSPD - Technical-Scientific and Professional Dimension;

PD - Pedagogical Dimension;

ORA - Other Relevant Activities;

- 16.2 The following parameters will be taken into account when assessing the Technical-Scientific and Professional Dimension (TSPD):
 - 1. Participation in research and development projects (R&DP) in the field of the tender, to be assessed through the following items;
 - 2. Publications and Communications in the field of the tender (PC), to be assessed through the following items in which they are an author, including co-authorship;
 - 3. Other Technical-Scientific Activities in the field of the tender (OTA), to be assessed using the following items;
 - 4. Assessment of the special focus on Social and Educational Intervention Policies and Projects in this Dimension (0 not at all relevant to 4 very relevant).

 - 1. Other Relevant Activities, to be assessed through the following items;
 - 2. Assessment of the special focus on Social and Educational Intervention Policies and Projects in this Dimension (0 not at all relevant to 2 very relevant).
