Under the terms of Article 18 of Regulation 558/2010 of 25 June, applications must be submitted exclusively in electronic format via the https://recrutamento.ipsantarem.pt platform.

Applications must be formalised by means of an application, to be filled in on the platform, in Portuguese, addressed to the President of the Polytechnic Institute of Santarém, containing the identification of the candidate, with full name, date of birth, nationality, civil identification number, address, telephone contact details and email address, as well as a list of accompanying documents.

The deadline for submitting applications is 30 working days, in accordance with Article 18 of Regulation 558/2010.

Candidates must enclose the following documents with their application, all in digital format:

Consent copy of the civil identification document, in digital format (PDF);

A simple copy of your tax identification number (if you don't have a national identity card), in digital format (PDF);

Declaration on honour, in which the candidate assures:

Not be disqualified or barred from exercising public functions;

Have complied with compulsory vaccination laws;

Have the physical strength and mental profile to fulfil the duties for which you are applying.

One (1) copy of valid proof of the professional title of nurse specialising in Child Health and Paediatric Nursing from the Nurses Association, in digital format (PDF);

One (1) copy of the curriculum vitae in digital, non-editable format (PDF), containing all the information relevant to the assessment of the application and the respective supporting documents, organised in accordance with the selection and ranking criteria set out in this notice.

Any other elements that the candidate considers may influence the assessment of their merit or constitute grounds for legal preference.

The curriculum vitae must be written in Portuguese; candidates from foreign countries may write it in English. The structure of the curriculum vitae must fully follow the operationalisation of the curricular assessment parameters and criteria, following the order of the assessment parameters and items to be assessed, respecting the sequence, numbering and coding and attaching documents validated by those responsible at the institution.

The supporting documents attached to the curriculum vitae must be presented in the original language in which they were issued and must be translated into Portuguese or English when these are not the original languages.

Whenever it deems it necessary, the jury may ask candidates by email to submit the originals of supporting documents attached to the curriculum vitae, as well as to submit additional documentation related to the curriculum vitae.

Failure to submit the documents required under the terms of this notice, or submitting them after the deadline, will result in exclusion from the tender.

Failure to submit the documents related to the curriculum vitae submitted by the candidate will result in the elements they are supposed to prove not being valued.

If you present a false document, you will be immediately excluded from the tender and reported to the competent authority for the appropriate procedure.

Candidates who do not fulfil the conditions for admission set out in point 9 of this notice will be excluded outright and will be notified of this intention in advance by email, for the purpose of holding a hearing of interested parties, under the terms of the Code of Administrative Procedure.

The documentation submitted by candidates will be destroyed if its return is not requested within a maximum of one year after the end of the respective tender procedure, and the documentation submitted that has been the subject of a legal challenge can only be destroyed or returned after the execution of a legal decision that cannot be appealed.



- 1. Technical-Scientific and Professional Performance (TSPP): 35 per cent
- 2. Pedagogical Capacity (PC): 40 %
- 3. Other Relevant Activities (OAR): 25 %
